Joshua Byers, late of Stockton County Durham, Timber Merchant. Died 17 September 1867. Probate granted herein at District Registry Durham 14 March. Resealed at the Principal Registry Dublin 17 July 1869

The will of Robert Byers late of Ballyboley County Down Gentleman deceased who died 2 December 1872 at same place was proved at Belfast by the oaths of William Byers of Ballyboley (Greyabbey) aforesaid Farmer and Robert Taylor of Newtownards Merchant (both in said County) two of the Executors 10 January 1869

Letters of Administration (with the Will annexed) of the personal estate of William Byers late of Gartnabroher County Cavan Farmer deceased who died 22 June 1873 at same place were granted at the Principal Registry to Sarah Byers of Gortnabroher aforesaid Widow of deceased and a Legatee 02 March 1874

The will of William Byers of Cornagrove County Cavan Farmer deceased who died 5 June 1875 at same place was proved at Cavan by the oath of James Byers of Derrylahan (Ballyjamesduff) County Cavan Farmer the sole Executor 30 June 1875

The Will of Agnes Byers late of Ballyboley County Down Widow deceased who died 21 April 1878 at same place was proved at Belfast by the oath of David McCormick Byers of Greyabbey same County Gentleman one of the Executors 04 October 1878
- Robert Byers**

Letters of Administration of the personal estate of Robert Byers late of Gallen County Cavan Farmer deceased who died 12 May 1878 at same place were granted at the Principal Registry to Sarah Byers of same place the Widow of said deceased 12 October 1878
- Jackson Byers**

Letters of Administration of the personal estate of Jackson Byers late of Charlemont County Armagh Esquire deceased who died 2 January 1882 at same place were granted at the Principal Registry to Jonathan S. Davies of Harrogate Yorkshire Hotel Proprietor and Daniel Davies of Swansea Glamorganshire Wales Merchant the Nephews 16 May 1882

Letters of Administration of the personal estate of Robert Byers late of Cliffin County Cavan Farmer deceased who died 25 February 1875 at same place were granted at Cavan to Anne Byres [*sic*] of Cliffin the Widow

The Will of William Byers late of Innishway County Fermanagh Farmer who died 20 December 1883 at same place was proved at Armagh by Mary Beatty (wife of John Beatty Farmer) of Innishway aforesaid the sole Executrix

Letters of Administration (with the Will annexed) of the personal estate of Robert Byers late of Cliffin Killinkere County Cavan Farmer who died 22 February 1875 [*sic*] at same place were granted at the Principal Registry to James Byers of Cliffin Farmer the Assignee of Anne Byers the Universal Legatee (Limited). [The Grant of Administration issued at Cavan on the 16 June 1883 having been cancelled]

The Will of Elizabeth Byers late of 12 Joy-street Belfast Widow who died 9 December 1885 at same place was proved at Belfast by William Harper of Victoria-street Belfast Merchant and David Sloan Thomson of Whiteabbey County Antrim Mill Manager the Executors

Letters of Administration of the personal estate of John Byers late of Gartnabraher County Cavan Farmer who died 16 May 1886 at same place were granted at Cavan to Jane Byers of same place the Widow
09 July 1886
- James Byers**

The Will of James Byers late of Denmore County Cavan Farmer who died 12 March 1888 at same place was proved at Cavan by John Hartley of Clifferna Stradone in said County Farmer one of the Executors
03 May 1889
- Alexander Byers**

The Will of Alexander Byers late of Kilbride County Antrim Farmer who died 18 July 1860 [*yes, this is the date as printed!*] at same place was proved at Belfast by Thomas Byers of Kilbride Farmer one of the Executors
02 July 1890
- Joseph Byers**
Effects £147
Letters of Administration of the personal estate of Joseph Byers late of Derrylahan County Cavan Farmer who died 11 September 1890 at same place were granted at Cavan to Mary Jane Byers of same place the Widow
21 October 1891
- Joseph Byers**

Letters of Administration of the personal estate of Joseph Byers late of Cornaden County Cavan Farmer who died 21 February 1892 at same place were granted at Cavan to Martha Byers of same place the Widow
28 May 1892

Sarah Byers

The Will of Sarah Byers late of Gallon County Cavan Widow who died 14 October 1891 at same place was proved at Cavan by Joseph Byers of same place Farmer the sole Executor 04 August 1892

Joseph McIlwaine
Effects £541
The Will of Joseph McIlwaine late of Lisanymore County Cavan Farmer who died 11 March 1895 at same place was proved at Cavan by John Johnston of Lisanymore Farmer the surviving Executor ?? 1895

John Byers
Effects £264. 10s. 6d
The Will of John Byers late of Ballywhisken County Down Farmer who died 9 November 1894 at same place was proved at Belfast by John Hall and William Ewart both of Ballywhisken Farmers the Executors 08 April 1895

James Byers
Effects £568
Probate of the Will of James Byers late of East-street Newtownards County Down retired Joiner who died 25 December 1895 granted at Belfast to James Steele of 183 and 185 Newtownards-road Belfast Draper Samuel C. Kelly of Francis-street Newtownards Merchant and the Reverend James Salters of Newtownards Presbyterian Minister 13 November 1896

Probate of the Will of Margaret Jane Ney late of Killacloughan County Cavan Spinster who died 28 September 1899 granted at Cavan to Joseph Brown of Coronary said County Farmer 30 October 1899

Edward Byers
Effects £51
Administration of the estate of Edward Byers late of Drumallaght County Cavan Farmer who died 12 May 1883 granted at Cavan to Mary Byers of Drumallaght the Widow 23 December 1899

Jane Byers
Effects £126
Probate of the Will of Jane Byers late of Dunover Greyabbey County Down Widow who died 18 March 1899 granted at Belfast to Alexander Dorrian Farmer 02 May 1900

Francis Byers
Effects £148. 9s. 8d
Administration of the estate of Francis Byers late of Dunover Greyabbey County Down Farmer who died 22 April 1902 granted at Belfast to John Byers Farmer 29 November 1901

Ann Byers
Effects £104. 16s. 11d
Administration of the estate of Ann Byers late of Holywood County Down who died 22 March 1902 at Downshire-road Holywood granted at Belfast to John Byers Dairyman the Husband 25 April 1902

Probate of the Will of Catherine Byers late of Rathkeale County Limerick Widow who died 8 February 1903 granted at Limerick to Stephen Casey Town Clerk and Daniel Guinane Farmer 28 February 1903

Probate of the Will of William Byers late of Ballyboley County Down Farmer who died 31 May 1904 granted at Belfast to William Byers and Francis Wright Farmers 19 August 1904
